



MINOR MODEL RELEASE

IN CONSIDERATION of the sum of One Dollar (\$1.00) and/or other good and valuable consideration, the adequacy and receipt of which is hereby acknowledged, I [Print Name of Model] (hereafter referred to as "Model") and the undersigned parent or legal guardian of Model, individually and on behalf of model, hereby agree with Corel Corporation and its legal representatives, subsidiaries, affiliates, successors, and assigns, including those acting under its permission or upon its authority including its employees, clients, licensees, contractors, subcontractors, purchasers and agencies (hereafter collectively referred to as "Corel"), as follows:

- a. We irrevocably grant to Corel the exclusive right to copy, use, re-use, modify, reproduce, publish, distribute and/or otherwise transmit any reproduction of the photograph(s) taken of Model on the _____ day of _____, 200__, by Corel and any picture, likeness, image, representation, negative, transparency, print, digital information or indicia, in whole or in part derived therefrom (collectively referred to as the "Representation"), with or without Model's name, for all purposes including without limitation advertising, trade, display, exhibition and editorial use, in all territories, in perpetuity, in all manner including electronically generated images, without limitation whatsoever.
b. We understand that editorial matter may accompany the Representation and that the Representation may be published or reproduced in any medium.
c. We irrevocably grant to Corel the right to make changes and/or additions to the Representation, whether true or fictional.
d. We hereby agree to waive and release any right that we may have to inspect and approve the finished product or copy that may be used in connection with the Representation and/or the use to which it may be applied.
e. We hereby agree to waive and release any claim that we or our successors or assigns have or may have based on statutory or other rights of privacy, publicity or any other right that may arise based on the use, modification, distribution or reproduction of the Representation permitted hereby.
f. We hereby release and discharge Corel from any and all liability by virtue of distortion, blurring, alteration, optical illusion, use in composite form and/or any and all usage of the Representation, whether intentional or otherwise, that may occur or be produced in the taking of the photograph or in any subsequent processing thereof, as well as any publication thereof. We expressly waive any moral rights we may have in the Representation.
g. We hereby release and discharge Corel from any claims for remuneration associated with any form of damage, whether foreseen or unforeseen, associated with the proper commercial or artistic use of the Representation.
h. We irrevocably acknowledge that Corel may assign its rights under this Model Release to any third party.
i. We irrevocably represent and warrant that we have not transferred or encumbered the rights granted to Corel herein.
j. We acknowledge and agree that the photography session during which the Representation was obtained was conducted in a completely proper and highly professional manner, and that this Model Release is willingly signed.
k. This Model Release shall be governed by the laws of the Province of Ontario, Canada. If any provision of this Model Release is invalid, void or unenforceable in any jurisdiction, then (i) that provision shall be construed so as not to apply for the purposes of such jurisdiction; (ii) this Model Release shall be construed so as to effect the widest possible grant of right possible without violating the law of jurisdiction; and, (iii) such provision shall be applicable to all other relevant jurisdictions.
l. By signing this Model Release, we acknowledge that the Model is a minor and certify that before signing this Model Release, we read it completely and understand it, and that we are bound by the terms and conditions contained herein, as is anyone who succeeds us, as our heirs and assigns. As the parent(s)/legal guardian(s) of the above-named Model, we hereby approve the foregoing on behalf of the Model and consent to the Representation's use, subject to the terms mentioned above. We undertake to do all things necessary to give full effect to this Model Release.
